

Disclosure of Potential Conflicts of Interest

In accordance with the policies and procedures established by The Endocrine Society by the Ethics Advisory Committee: Ethical Aspects of Conflicts of Interests (http://www.endo-society.org/ethics/upload/coi_guideline.pdf), all journals published by The Endocrine Society require that each author disclose any potential financial conflicts of interest before a paper is published in *Endocrinology*, *Molecular Endocrinology*, *The Journal of Clinical Endocrinology and Metabolism*, or *Endocrine Reviews*.

The authors are requested to provide disclosure information when submitting their revised manuscript or, if the initial submission is recommended for publication without modification, upon being informed that the manuscript is provisionally accepted pending the submission of disclosure information.

The disclosure of this information is not intended to prevent the publication of papers in The Endocrine Society journals but rather is to identify openly any relationships with pharmaceutical companies, companies that make or supply products or services related to the subject matter of the paper, or other financial interests. With full disclosure the editors and readers can make informed decisions about submitted and printed papers in the journals.

Please note:

- It is the responsibility of the corresponding author to ensure that all authors sign and submit the Author Disclosure form.
- The corresponding author is also responsible for summarizing the disclosures in a paragraph that is to appear in the published article indicating whether there are any disclosures or not.
- This summary will appear in the PDF of accepted papers on The Endocrine Society journals Rapid Electronic Publication sites and in the printed journal. Final acceptance is contingent on the inclusion of the summary and on the receipt of all signed forms at the editorial office.

Instructions for Author Disclosure Summary:

- (1) Briefly collate all information in all author summaries according to the format Author initials, then category, then company name. The relevant categories are “has nothing to declare”, “is employed by”, “was previously employed by”, “consults for”, “has previously consulted for”, “has served as an expert witness for”, “received lecture fees from”, “has equity interests in”, “received grant support (dates) from”, “is an inventor on (country)(patent number)”, “receives royalties from”.
- (2) Authors may also add other pertinent categories.
- (3) Only report potential conflicts of interests with entities directly related to the material being published.

EXAMPLES: The disclosure of a manuscript by authors A.B., C.D., E.F. and G.H. may appear as follows:

DISCLOSURE STATEMENT: A.B., E.F. have nothing to declare. C.D. was previously employed by and has equity interests in (company X). C.D. consults for (company Y). G.H. was previously employed by and received lecture fees from (company X). G.H. is an inventor on (country)(patent number).

Or

DISCLOSURE STATEMENT: The authors have nothing to disclose.
